Other Bonus Authority Extensions (DFAS Item L-83)

Attached is Interim Change 6-03 to Chapters 9 and 20 of the Defense Financial Management Regulation (DoDFMR), Volume 7A. It is effective December 02, 2002. This change extends the expiration date of special pay and bonus authorities for enlistment and reenlistment, for critical military skills retention and for aviation officer retention to December 31, 2003.

This is a routine change and the result of directed action that does not affect existing policies. A draft of this change was not provided for comments.
