



HARDSHIP DUTY PAY FOR ASCENSION AAF AND ANTIGUA AS

1. The following change will require action to stop HDP-L(CP) and start HDP-L(DA) for those enlisted personnel on Ascension Island who are currently receiving HDP under the provisions that "grandfathered" HDP-L(CP) payments on January 1, 2001. HDP-L(CP) and HDP-L(DA) may not be paid concurrently.

2. Change Figure 17-1, Hardship Duty Location Pay for Designated Areas, as follows:

a. Insert a new entry for **Antigua AS**, at a rate of **\$50**, effective **April 18, 2002**.

b. Insert a new entry for **Ascension AAF**, at a rate of **\$150**, effective **April 18, 2002**.
