

MEMORANDUM FOR DIRECTOR, MILITARY PAY OPERATIONS, DEFENSE
FINANCE AND ACCOUNTING SERVICE (DFAS-PM/CL)

SUBJECT: Interim Change to the Department of Defense Financial Management Regulation (DoDFMR), Volume 7B, Regarding Extension of Expiration Date on Certain Draw-down Transition Authorities (DFAS Item M-5)

The attached is Interim Change R 04-03 to Chapter 1 of the DoDFMR, Volume 7B. Public Law 107-314, Section 554, December 2, 2002, extends the expiration date for Temporary Early Retirement Authority (TERA) to September 1, 2002. This change is effective January 1, 2002.

This is a routine change and the result of directed action that does not affect existing policies. A draft of this change was not provided for comments. Assignment of the interim change number is your authority to initiate a procedural modification to implement this change. Use the attached to initiate the formal change to the DoDFMR, Volume 7B.

1. Subparagraph 010101.A., Sentence 5, revise to read:

“(The Secretary of the Military Department concerned may reduce the 20 years of creditable service requirement to 15 years for the period beginning October 23, 1992, and ending on September 1, 2002.)”

2. Table 1-1, Notes 1, 2, and 3, revise to read:

1. Paragraph 010102(10 U.S.C., 3683 (repealed), 3925, 8683, (repealed) and 8925). Under Temporary Early Retirement Authority, the Secretary of the Military Department concerned may reduce the 20 years of creditable service requirement to 15 years of creditable service. Public Law 107-314, Section 554, December 2, 2002, extended this authority to September 1, 2002.
2. Paragraph 010103 (10 U.S.C. 3926, 6321, 6323, and 8926). Under Temporary Early Retirement Authority, the Secretary of the Military concerned may reduced the 20 years of creditable service requirement to 15 years of creditable service. Public Law 107-314, Section 554, December 2, 2002, extended this authority to September 1, 2002.
3. Paragraph 010104 (CCA 1949, Section 511; 10 U.S.C. 6321 and 6322). Under Temporary Early Retirement Authority, the Secretary of the Military Department concerned may reduce the 20 years of creditable service requirement to 15 years of creditable service. Public Law 107-314, section 554, December 2, 2002, extended this authority to September 1, 2002.
